

The Chief Operating Officer (COO) of H+H International A/S coordinates the Group's activities regarding Health & Safety, supports and assists the Group entities in Health & Safety related matters within operations, commercial and administrative activities.

The Managing Director of H+H UK Limited is ultimately responsible for health and safety within the Company. In the UK the Managing Director has appointed the Operations Director to be the Safety Director, to facilitate and monitor the operation of this policy. All employees are encouraged to communicate any opportunities they have identified for health and safety improvements to their Line Manager, Health and Safety Manager or to other Directors or Managers.

The responsibilities of management and individuals and this policy are highlighted in induction training, which is also used to inform new employees where they can refer to this policy and associated safety documentation. Induction training includes coverage of safety topics specific to the Company's activities and is repeated as refresher training for existing employees. Training in health and safety is undertaken to ensure that all employees are equipped to support the aims of, and comply with, this policy.

This policy statement and other health and safety documents are incorporated in the Company's Integrated Management System, reviewed at least annually and revised as necessary. Changes will be made considering new legislation, stakeholder feedback, operating practices, specifications and technology.
